

Participate in the Virtual MPO Public Transportation Task Force Meeting on September 10, 2020

FOR IMMEDIATE RELEASE, SARASOTA/MANATEE, FL, September 2, 2020 – **NOTIFICATION IS GIVEN** that the Public Transportation Task Force (PTTF) meeting will be held at 1:00 p.m. on Thursday, September 10, 2020. Meeting materials and information regarding technology and access will be posted to the MPO website at www.mympo.org on **Wednesday, September 2, 2020.**

For the protection of the community, all Sarasota/Manatee Metropolitan Planning Organization (MPO) meetings will be available to the public online and by telephone to avoid convening more than ten people during the current COVID-19 State of Emergency from **March 9 to September 30, 2020.** Public access and public comment opportunities will be provided as permitted in [Executive Order 20-69 and extended by Executive Order 20-150](#) for local government meetings, allowing the use of communications media technology, such as telephonic and video conferencing.

There are four (4) ways for the public to participate:

1. Written comments will be accepted before, during, and after the meeting. All written comments will be included as part of the official public record of the meeting. 2. The **PTTF meeting** will be live streamed on **Thursday, September 10, 2020 at 1:00 p.m.** The public can view the meeting and comment during the meeting using the comment box at <https://publicinput.com/Q742>.
3. The public may call-in by phone and leave voice comments. Telephone Number 1-855-925-2801; Meeting code 8196.
4. For those wishing to address members of the PTTF directly, you are requested to provide a written request in advance. Please email Nanette Eubanks, Clerk to the Board, at Nanette@mympo.org by **1:00 p.m. on Thursday, September 10, 2020**, for your comments to be distributed to PTTF members prior to the meeting. Please provide the following information in the email:

 - b. Please include the following information in the body of the email: 1) Name, email, and phone number; 2) The agenda item you wish to address; 3) A summary of your public comment (3000-character limit)
 - c. Following the receipt of the email, instructions will be sent on how to join the virtual meeting to speak once the Chair calls on you during the public comment period.

The MPO rules of procedure, decorum, and policy governing the public comment period, shall be followed, and enforced in the same manner as if the meeting were held in person. During the public comment period, the Chair will ask the public to speak based on the written requests to speak in the order they are received.
